


Executive Summary

For FY 2011 the age and gender of committed juvenile offenders remained overwhelmingly males between 15 and 17 years of age. In FY 2011 there was a 5% decrease in Caucasian youth, a 14% decrease in African-American youth, and a 6% decrease in youth of other ethnicities committed to DYS. In FY 2011 the number of youth recommitted to DYS decreased 20 percentage points and the number of youth committed for felony type offenses decreased by 8%. The number of commitments to DYS from FY 2008 through FY 2011 averaged around 562 annually. In FY 2011 the number of commitments decreased by 10% from the prior year.


Population Profiles July 2010 - June 2011




Profiles of Juveniles Committed July 2010 - June 2011






Profiles of Juveniles Committed July 2010 - June 2011




FY11 Commitments by Age




Profiles of Juveniles Committed July 2010 - June 2011




FY11 Commitments by Gender




Profiles of Juveniles Committed July 2010 - June 2011









* Since the Hotline and the Investigations units are two separate sections within the Arkansas State Police, the Hotline may accept an incident called in, then later the incident will not be investigated by the Investigations Unit after review of the circumstances. The DYS IAU never receives a follow-up on these reports to know whether they were ever investigated. Some of these incidents occurred prior to the juvenile being committed to DYS. The IAU does not receive notification of the findings in these incidents. Some incidents that are reported in one quarter may not be finalized by the State Police until sometime within the next quarter.



Incident Reports for FY 2011




Incidents Reported to Hotline for FY 2011




