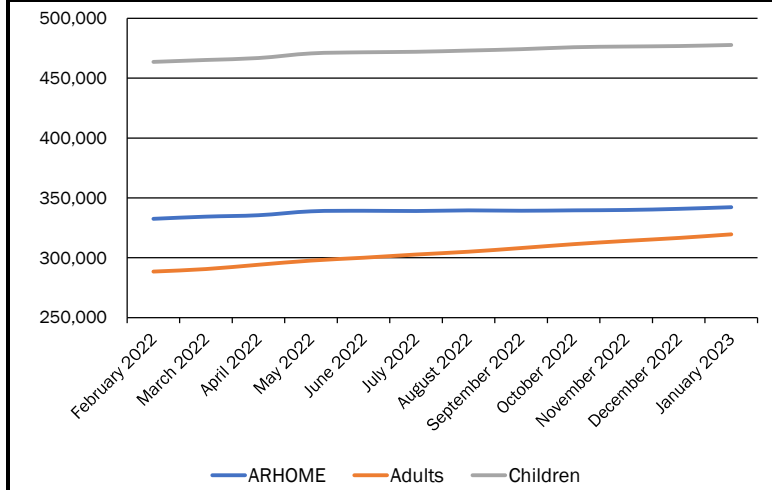

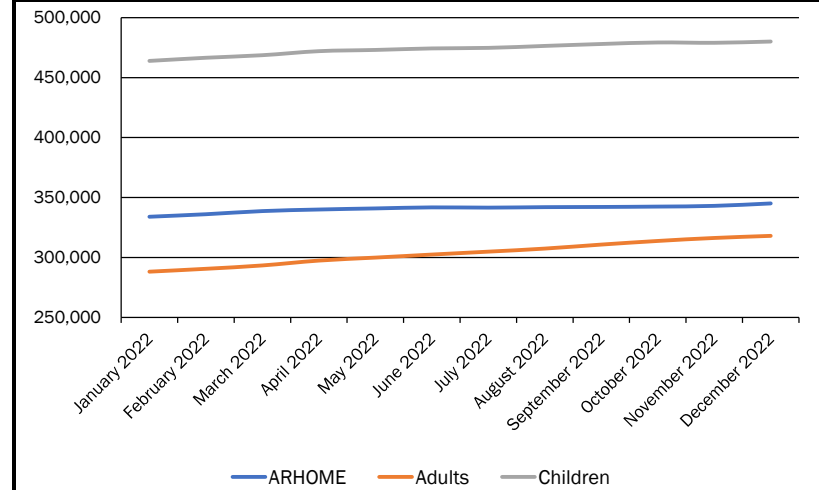

NOTE: Arkansas Works / ARHOME program has reconciliations done on a periodic basis for cost sharing reduction payments and premium payments made for individuals above 100% FPL. These payments are not included in the claims processing payments due to the material impact on a per member per month amount in the month paid despite the payments being made for previous months. ARHOME Premiums and Cost Sharing increases are due to rate changes effective January 1st, 2022. January, March, June, September, November, December adjustments include Annual Cost Sharing Reconciliations to QHP Carriers paid quarterly. For the month of October we received 2021 MLR adjustment.
