## Public Hearing on Update to Medicare and Medicaid Crossover Billing Rules - Zoom Public Hearing Transcript 6/26/2024 @ 11:00 a.m. CST

**Mac Golden:** Good morning, everyone, and welcome to a public hearing on a rule regarding an update to Medicare and Medicaid Crossover Billing rates due to technical issues. Today's hearing will be without video. Anita Castleberry, The Division on Medical Services will be announcing the notice of rulemaking. Then we will open the floor for public comments. Please utilize the raise hand feature via Zoom, if you would like to make a comment on record. All official responses to public comments will appear on the DHS proposal rule website after the public comment period. Ms. Castleberry will now read the notice of rulemaking.

**Anita Castleberry:** The Department of Human Services announces for a public comment period of thirty (30) calendar days a notice of rulemaking for the following proposed rule under one or more of the following chapters, subchapters, or sections of the Arkansas Code: §§ 25-10-129, 20-76-201, and 20-77-107.

Effective September 1, 2024, the Division of Medical Services (DMS) updates the billing rules for Medicare Crossover reimbursement and adds a new field to its Medicaid Management Information System to improve how the claims are paid and reported. DMS adds a separate copayment field to electronic claims to identify the correct amounts being paid for Medicare copayments apart from coinsurance amounts. These updates result in cost savings of \$225,000.000 per year.

The proposed rule is available for review at the Department of Human Services (DHS) Office of Policy and Rules, 2nd floor Donaghey Plaza South Building, 7th and Main Streets, P. O.
