

# Pharmacy Owner Sentenced to Prison for Health Care Fraud

A New York woman was sentenced to 78 months in prison for defrauding health care programs, including more than \$6.5 million from Medicare Part D plans and Medicaid drug plans.

According to court documents, Aleah Mohammed, 37, of Queens, pleaded guilty to one count of mail fraud, one count of health care fraud, and one count of conspiracy to commit health care fraud.

According to court documents, Mohammed was an owner and operator of five pharmacies: Superdrugs Inc., Superdrugs I Inc., Superdrugs II Inc., S&A Superdrugs II Inc. and Village Stardrugs Inc. Between 2015 and 2020, Mohammed used these pharmacies to defraud health care programs, including Medicare and Medicaid, by submitting claims for prescription drugs that were not dispensed, not prescribed as claimed, not medically necessary, or that were purportedly dispensed during a time when the pharmacy was no longer registered with the State of New York. The fraudulent claims included claims for expensive prescription drugs for the treatment of the human immunodeficiency virus (HIV).

Mohammed used proceeds of the scheme to purchase herself luxury items, such as jewelry and a Porsche.

Assistant Attorney General Kenneth A. Polite, Jr. of the Justice Department's Criminal Division; U.S. Attorney Breon Peace for the Eastern District of New York; Special Agent in Charge Scott J. Lampert of the U.S. Department of Health and Human Services Office of Inspector General's (HHS-OIG) Office of Investigations; Assistant Director Luis Quesada of the FBI's Criminal Investigative Division; and Assistant Directorin-Charge Michael J. Driscoll of the FBI's New York Field Office made the announcement.

HHS-OIG and the FBI investigated the case.

Trial Attorneys Andrew Estes and Patrick J. Campbell of the Criminal Division's Fraud Section prosecuted the case.

#### Biden-Harris Administration Announces a New Way for Medicare Beneficiaries to Get Free Over-the-Counter COVID-19 Tests

Starting April 4, 2022, more than 59 million Americans with Medicare Part B, including those enrolled in a Medicare Advantage plan, now have access to over-the-counter COVID-19 tests at no cost. This is in addition to the two sets of four free at-home COVID-19 tests Americans can continue to order from https://www.covid.gov/tests.

People with Medicare can get up to eight tests per calendar month from participating pharmacies and health care providers for the duration of the COVID-19 public health emergency.

This is the first time that Medicare has covered an over-the-counter self-administered test at no cost to beneficiaries.

A list of eligible pharmacies and other health care providers that have committed publicly to participate in this initiative can be found <u>here</u>. People with Medicare should check with their pharmacy or health care provider to find out whether they are participating.

## The BENES 2.0 Act

(Beneficiary Enrollment Notification and Eligibility Simplification (BENES) Act,) passed in 2021, people who enroll during Medicare's General Election Period (GEP) will have coverage effective on the first day of the month after they enroll, eliminating some gaps in coverage.

The Benes 2.0 Act would require the federal government to provide advance notice to people approaching Medicare eligibility about basic Medicare enrollment rules, filling a longstanding gap in federal outreach and education.

For each 12-month period that an individual delays enrollment in Medicare Part B past age 65, they will have to pay a 10% Part B premium penalty, unless they have insurance based on their or their spouse's current job-based insurance or are eligible for a <u>Medicare</u> <u>Savings Program</u> (MSP), which helps pay Medicare costs for people with limited income and savings.

In most cases, people will have to pay the Medicare Part B penalty every month for as long as they have Medicare.

People who are enrolled in Medicare because of a disability and paying Part B premium penalties will no longer have to pay the premium penalty once they turn 65.

Extra time to sign up for Medicare is available for anyone who wasn't able to contact the Social Security Administration because of problems with Social Security's telephone system between January 1, 2022, and December 30, 2022.



# You're eligible for extra time to sign up for Medicare IF all of these apply:

- → You're eligible to sign up for Medicare between January 1, 2022 - December 30, 2022 and were unable to because of problems with Social Security's telephone system.
- $\rightarrow$  You haven't signed up for Medicare yet.
- $\rightarrow$  You sign up for Medicare by December 30, 2022.

How do I sign up during this time?

#### Social Security to Offer Self-Attestation of Sex Marker in Social Security Number Records

Kilolo Kijakazi, Acting Commissioner of Social Security, announced that the agency will offer people the choice to self-select their sex on their Social Security number (SSN) record. The agency anticipates this option will be available in the fall of 2022.

"The Social Security Administration is committed to reducing barriers and ensuring the fair treatment of the LGBTQ+ community by updating our procedures for Social Security number records," said Acting Commissioner Kijakazi. "This policy change will allow people to self-select their sex in our records without needing to provide documentation of their sex designation." People who update their sex marker in Social Security's records will need to apply for a replacement SSN card. They will still need to show a current document to prove their identity, but they will no longer need to provide medical or legal documentation of their sex designation once the policy change becomes effective. SSN cards do not include sex markers.

In February 2022, the agency issued guidance instructing employees to accept evidence documents that contain nonbinary identifiers (e.g., "X") for original SSN and replacement SSN card applications, and other updates to the agency's internal SSN records. The agency is exploring possible future policy and systems updates to support an "X" sex designation for the SSN card application process.

Thanks to younger Americans, the share of LGBTQ people in the US population has continued to grow.

The percentage of Americans identifying as LGBTQ grew from 3.5 percent in 2012 to 7.1 percent in 2021, according to a poll conducted by <u>Gallup</u>.

Younger populations are driving the uptick in the percentage of queer people in the population, according to Gallup, which interviewed more than 12,000 adults from every state as part of an annual report on LGBTQ demographics in America. A whopping 21 percent of the Generation Z population — which includes those born between 1997 and 2003 — identifies as part of the LGBTQ community.

Among Millennials, 11 percent say they identify as LGBTQ. That number dropped to four percent among Generation X respondents, just under three percent for Baby Boomers, and about one percent for Traditionalists, which encompasses those born before 1946.

The share of overall respondents from the Generation Z population has grown from seven percent to 12 percent as that demographic has entered adulthood. Traditionalists, meanwhile, now make up eight percent of respondents.

Among all respondents, 6.6 percent did not elaborate on their sexual orientation or gender identity.

Notably, the majority of LGBTQ individuals polled — 57 percent say they identify as bisexual, and bisexual people represent four percent of the overall population in the United States. Gay respondents make up 21 percent of the queer population, compared to 14 percent for lesbian individuals, 10 percent for transgender folks, and 4.3 percent of those classified as "other," which includes queer and same-gender loving folks.

Generation Z boasts more than half of the bisexual respondents as any other group. Six percent of women identify as bisexual compared to two percent of men.

Gallup also recently found that the percentage of LGBTQ Americans married to a same-sex partner has remained steady at 10 percent. Six percent of queer adults are in samesex domestic partnerships, which is down slightly, and the share of LGBTQ people who have never married has gone up to 53 percent.

## Hospital System Agrees to Pay \$22.7 Million

April 15, 2022

<u>Walla Walla, WA</u> — Providence Health & Services Washington has agreed to pay \$22,690,458 to resolve allegations that it fraudulently billed Medicare, Medicaid, and other federal health care programs for medically unnecessary neurosurgery procedures. Providence St. Mary's paid neurosurgeons based on a productivity metric that provided them a financial incentive to perform more surgical procedures of greater complexity. The settlement says two neurosurgeons at the hospital performed surgeries on candidates who were not appropriate, created an excessive level of complications and negative outcomes, and failed to document properly.

## What Can You Do to Stop COVID-19 Fraud?

- Do not give out your Medicare number to anyone other than your doctor, health care provider, or other trusted representative.
- Protect your Medicare number and treat your Medicare card like a credit card. Never provide your Medicare number to anyone who contacts you through unsolicited calls, texts, or emails.
- Be cautious of anyone who comes to your door offering free coronavirus testing, treatment, or supplies.
- Don't click on links from sources you don't know, which could put your computer or device at risk. Make sure the anti-malware and anti-virus software on your computer are up to date.
- Don't post on social media that you are getting tested for or receiving a vaccination for COVID-19. Posting content that includes your date of birth, health care details, or other personally identifiable information can put you at risk as these details can be used to steal your identity.

- Be cautious when purchasing medical supplies from unverified sources, including online advertisements and email/phone solicitations.
- Be cautious of COVID-19 survey scams that offer money or gifts in exchange for personal, medical, or financial information.
- Do your homework before making a donation to a charity or crowdfunding site due to a public health emergency. Be particularly wary of any charities requesting donations by cash, by gift card, or wire transfer.

## How Your Senior Medicare Patrol (SMP) Can Help

Your local SMP is ready to provide you with t he information you need to **PROTECT** yourself from Medicare fraud, errors, and abuse; **DETECT** potential fraud, errors, and abuse; and **REPORT** your concerns. Your SMP can help you with your questions, concerns, or complaints about potential fraud and abuse issues. It also can provide information and educational

## **CARDIOVASCULAR Genetic Testing Fraud**

## What is Cardiovascular Genetic Testing Fraud/Scams?

Cardiovascular genetic testing fraud occurs when Medicare is billed for a cardio-type test (cheek swab) or screening that was not medically necessary and/or was not ordered by a beneficiary's treating physician.

## What You Should Know:

Scammers are offering Medicare beneficiaries cheek swabs for genetic testing to obtain their Medicare information for fraudulent billing purposes/medical identity theft. If Medicare denies the claim, you could be responsible for the entire cost, which averages \$9,000 to \$11,000.

- You receive an <u>unsolicited</u> call from someone stating your doctor *or cardiologist* requested that you have the testing done and they will send you a cheek swab testing kit.
- Caller ID may even show your doctor's name or phone number.
- A company calls offering you "free" or "at no cost to you" testing without a treating physician's order and then bills Medicare. Many scammers 'coach' you on what to say when transferred on to another 'agent.'
- Billing Medicare (usually thousands of dollars) for a broad range of cardiac genetic tests that you
  did not request or even receive.
- Report it to the AR SMP 866-726-2916

If you fall victim and give your Medicare number to a scam caller, report it to the AR SMP at **866-726-2916.** 

You will need to read your Medicare Summary Notices (MSNs) to look for charges for things you did not receive, and that your doctor did not order, like charges for braces (knee, back, wrist); or lab tests (especially related to COVID-19 and genetic testing.

#### TO PREVENT HEALTHCARE FRAUD—

Protect Personal Information

- \* Treat Medicare/Medicaid and Social Security numbers like credit card numbers.
- \* Remember, Medicare will not call or make personal visits to sell anything!
- \* READ and SAVE Medicare Summary Notices (MSN) and Part D Explanation of benefits (EOB), but **shred** before discarding.

#### Detect Errors, Fraud, and Abuse

- \* Always review MSN and EOB for mistakes.
- \* Compare them with your Personal Health Care Journal.
- \* Visit **www.mymedicare.gov** to access your personal account online to look for charges for something you did not get, billing for the same thing more than once, and services that were not ordered and/or you never received.

#### Report Mistakes or Questions

- \* If you suspect errors, fraud, or abuse, report it immediately! Call your provider or plan <u>first</u>.
- \* If you are not satisfied with their response, call the Arkansas SMP.

- \* Retired seniors;
- \* Retired health-care providers; or
- \* Retired professionals, *e.g.*, teachers, accountants, attorneys, investigators, nurses.
